

The Wellcome Trust's open access policy: monographs and book chapters

We are committed to ensuring that the published outputs of Wellcome Trust-funded research are made freely available, so that this knowledge can be built on by the widest possible audience in a manner that maximises health and public benefit, and fosters a richer research culture.

The Wellcome Trust's open access policy applies to research papers, monographs and book chapters. This leaflet provides information for researchers making their **monograph or book chapter** open access. Specifically, the policy:

- (1) applies to all original scholarly monographs and book chapters authored or co-authored by Trust grantholders as part of their grant-funded research. The policy does not apply to textbooks, 'trade' books, general reference works or works of fiction, or to collections edited but not authored by Trust grantholders
- (2) requires electronic copies of monographs and book chapters to be made available through PMC Bookshelf and Europe PMC as soon as possible, and in any event within six months of publication
- (3) The Wellcome Trust will make funds available for the payment of publisher's open access monograph processing charges. Your grant will be supplemented, and your institution will be reimbursed by the Trust. Funding is also provided where a research grant has ended. Contact openaccess@wellcome.ac.uk regarding reimbursement of these costs
- (4) Where a publishing fee is levied, such works must be available without embargo and be licensed in ways which support their reuse. Although the Creative Commons, Attribution licence (CC-BY) is strongly preferred, we will accept non-commercial and/or non-derivatives licences (i.e. CC-BY-NC, or CC-BY-NC-ND)

How to comply

- (1) Check that the Wellcome Trust policy applies to the monograph or book chapter you plan to publish.
- (2) Check that the publisher you wish to publish with has a publishing policy compliant with the Wellcome Trust Grant Conditions.

Check your preferred publisher's website for their open access policy. If the publisher does not yet have an open access policy for monographs we encourage you to speak to their editorial staff as many publishers are open to being approached by Wellcome Trust grantholders to discuss their open access options. Alternatively, please email openaccess@wellcome.ac.uk and we will work with you and the publisher to see if it is possible to publish your work open access.

- (3) If the publisher has an open access option for which a fee must be paid, ensure that they:
 - Offer an open licence, preferably Creative Commons, Attribution licence (CC-BY)

- Deposit your monograph or book chapter in PMC Bookshelf immediately upon publication using this form: <https://oadeposit.wellcome.ac.uk/oa/>

- Understand that an html and PDF version of your work will be freely available

- (4) If the publisher does not offer a paid open access option, ensure that they allow you to self-archive the peer-reviewed author manuscript in PMC Bookshelf and make it freely available within six months of publication.

- (5) If you choose the paid open access option inform the publisher. Otherwise self-archive your manuscript at: <https://oadeposit.wellcome.ac.uk/oa/>
